1. Approval of Minutes

The minutes of the November 4, 2005 meeting were approved as presented.

2. Report of the Committee Chair

The Chair thanked the members for their work on the committee in 2005. He noted that he along with Councilmembers Edmonds, Pelz, and Compton would be leaving office at the end of the year.

The Chair also noted that the January 2006 meeting would be cancelled because both the Chair and Vice Chair of the committee would be leaving office at the end of 2005.

3. Metropolitan Water Pollution Abatement Advisory Committee (MWPAAC) Report

Dave Christensen, MWPAAC Chair, noted that generally MWPAAC is in support of the ordinances on the agenda for action at the meeting. He also noted that in January MWPAAC will begin working with Wastewater Treatment Division on the CSI projects.
