#### 1. Approval of Minutes

#### 2. Report of the Committee Chair

Chair Phillips welcomed the members. He noted that a packet of answers to questions raised at the June RWQC meeting has been distributed to members. Chair Phillips also noted that the August 9, 2006 meeting of the RWQC would be cancelled due to the King County Council Summer Recess. The next RWQC meeting will be held on September 13, 2006.

Ms. Hague, Committee Vice-Chair, noted progress on the county-convened regional water supply planning process that includes the major water purveyors in the county. They have convened for the purpose of taking a long-range, broad-based look at water supply issues. The group has divided into technical committees looking at climate change, reclaimed water, tributary stream flow, source exchange strategies, and small water systems. She reported on the allocation of funds among the technical groups.

Beth Mountsier, Committee Staff, and Jane Lamensdorf-Bucher, Regional Water Planning Program Manager, King County Department of Natural Resources and Parks, responded to questions from the members.

#### 3. Metropolitan Water Pollution Abatement Advisory Committee (MWPAAC) Report

Dave Christensen, MWPAAC Chair, briefed the committee regarding the following items discussed at the MWPAAC meeting: 1) I/I projects, 2) overall capital improvement for the system conveyance improvement projects, and 3) briefing on MBR pilot studies.
