A MOTION approving reporting formats for monitoring expenditures and revenues associated with the Green River Homicide Investigation and *State v*. *Ridgway* case.

WHEREAS, the 2003 Budget Ordinance, Ordinance 14517 contains provisos requiring the office of management and budget, the sheriff's office, the prosecuting attorney's office, the superior court and the office of the public defender to develop quarterly reporting formats to monitor actual expenditures and revenues associated with the Green River homicides investigation and the *State v. Ridgway* case, and

WHEREAS, clear and consistent reporting quarterly reporting formats for the *State v. Ridgway* case and the Green River homicides investigation will provide a historical record, will allow current costs to be monitored and will assist in the development and review of future appropriations, and

WHEREAS, the office of management and budget has submitted formats for tracking these expenditures and revenues on a quarterly basis;

NOW, THEREFORE, BE IT MOVED by the Council of King County:

The quarterly reporting formats for actual expenditures and revenues associated with the Green River homicides investigation and *State v. Ridgway* case are hereby approved.
