A MOTION acknowledging the receipt of a report from the safety of newborn

children task force regarding improving awareness in King County of the Safety

WHEREAS, Motion 14104 created the safety of newborn children task force to examine ways to improve the implementation of the Safety of Newborn Children law throughout King County, and

WHEREAS, the task force was charged with reporting on: how King County can engage in an ongoing, regionally consistent public information campaign about safe surrender of newborns; how King County can work collaboratively with the state to obtain useful, timely data on instances of safe surrender and newborn abandonment; and whether the safe surrender locations for accepting newborns should be expanded through state legislation, and
