## BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. The collective bargaining agreement negotiated by and between King County and Professional and Technical Employees, Local 17 (Information Technology) representing employees in the departments of King County information technology, executive services, community and human services and judicial administration and in King County elections, which consists of Attachments A, B and C, and five memoranda of agreement, which consists of Attachments D, E, F, G and H, to this ordinance, are hereby approved.

SECTION 2. Terms and conditions of said agreements shall be effective from July 1, 2013, through and including December 31, 2016.
