AN ORDINANCE concurring with the recommendation of the hearing examiner

County Title 21A, as amended, by modifying the zoning map to reflect this

reclassification.

## BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. This ordinance adopts and incorporates the findings and conclusions of the July 31, 2009,

report and recommendation of the hearing examiner, filed with the clerk of the council on August 26, 2009, upon the application of NB Partners, LLC to reclassify certain property described in department of development and environmental services file no. L09TY401.

SECTION 2. The recommendation of the hearing examiner to reclassify the subject property from CB (Community Business) to Urban Residential-48 (R-48; 48 units/acre) is hereby adopted. Upon this ordinance becoming effective, the land use services division shall amend the official zoning maps of King County to reflect this action.
