## BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. The collective bargaining agreement and memorandum of agreement negotiated between King County and International Brotherhood of Electrical Workers, Local 77 (Department of Transportation (Road Services), Office of Information Resource Management) representing employees in the departments of natural resources and parks, public health, transportation and the office of information resource management and attached hereto are hereby approved and adopted by this reference made a part hereof.

SECTION 2. Terms and conditions of said agreements shall be effective from January 1, 2008, through and including December 31, 2010.
