AN ORDINANCE relating to no shooting areas; establishing a no shooting area

within the Ravensdale and Crow voting precincts; and adding new sections to

K.C.C. chapter 12.68.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

NEW SECTION. SECTION 1. There is hereby added to K.C.C. chapter 12.68 a new section to read as

follows:

A. The shooting of firearms is prohibited and a no shooting area is established within the Ravensdale

voting precinct.

B. The area is all of Section 35, Township 22 North, Range 6 East, W.M. The area is bounded by SE

272 St on the north, 244 Avenue on the west, SE 288 Street on the south and 260 Avenue SE on the east.

<u>NEW SECTION. SECTION 2.</u> There is hereby added to K.C.C. chapter 12.68 a new section to read as follows:

A. The shooting of firearms is prohibited and a no shooting area is established within the Crow voting precinct.

B. The area is in those portions of Sections 2 & 3, Township 21 North, Range 6 East, W.M. that are bounded by SE 288th Street (south line of Section 35) on the north, Maple Valley-Black Diamond Rd on the west, SE 305 Street (Black Diamond corporate limits) on the south and Black Diamond-Ravensdale Rd on the east.
