AN ORDINANCE authorizing the King County executive to execute an

interlocal agreement with the city of Redmond for the purpose of designing and

constructing improvements to Northeast Union Hill Road within the city.

STATEMENT OF THE FACTS

1. The county has a capital improvement project (CIP # 100992) on Northeast Novelty Hill

Road in unincorporated King County.

2. Phase 1 of the CIP consists of widening and improving ortheast Union Hill Road,

196th /195th Avenue Northeast, and Northeast Novelty Hill Road.

3. A segment of the CIP, Phase 1 on Northeast Union Hill Road extends approximately eight

hundred feet into the city.

- 4. Phase 1 of the CIP will provide a transition within the city of Redmond from the newly constructed roadway in unincorporated King County to the existing roadway in the city.
- 5. Improvements within the city are essential to the safe and efficient operational design for the continuation of the county road system.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. The county executive is hereby authorized to execute an interlocal agreement with the city of Redmond, substantially in the form of Attachment A to this ordinance, for the purpose of designing and constructing improvements to Northeast Union Hill Road within the city.
