transportation, public health, homeland security, salmon recovery, flood control, affordable housing and other

important needs, and

WHEREAS, the King County council and the King County executive will continue to review congressional developments for possible revisions of King County's 2015 (FY 2016) federal legislative goals;

NOW, THEREFORE, BE IT MOVED by the Council of King County:

The King County council hereby adopts the King County 2015 (FY 2016) Federal Legislative Agenda, Attachment A to this motion, and King County 2015 (FY 2016) Federal Policy Interests, Attachment B to this motion, as King County's highest priorities for federal action in the 2015 (FY 2016) congressional cycle.
