BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

<u>SECTION 1.</u> There is hereby approved and adopted an ordinance making a supplemental appropriation

of \$4,278,138 to the sheriff to implement the King County Police Officers Guild Collective Bargaining

Agreement for the fiscal year ending December 31, 2009.
