AN ORDINANCE relating to the fee for consolidated site review of single-

family residential development; and adding a new section to K.C.C. chapter

27.10.

## BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

<u>SECTION 1.</u> A. Section 2 of this ordinance creates a fee for consolidated site review for single-family residential development.

B. The fee is assessed under K.C.C. chapter 27.10.

<u>NEW SECTION. SECTION 2.</u> There is hereby added to K.C.C. chapter 27.10 a new section to read as follows:

Fee for consolidated site review for single-family residential development. The fee for the consolidated site review for single-family residential development under K.C.C. 21A.24. (Ordinance 15051,

File #: 2004-0508, Version: 2

Section 234) shall be one thousand eight hundred and fifty dollars. The department may charge additional fees for activities not covered by the consolidated review, including, but not limited to, review to determine consistency with conditions established by the consolidated review, building permit review, inspections and mitigation.

SECTION 3. Effective date. This ordinance takes effect January 1, 2005.
