WHEREAS, K.C.C. chapter 1.10 provides for the publication and distribution of local voters' pamphlets in conformity with the provisions of chapter 29A.32 RCW for annual general elections held in King County, and

WHEREAS, RCW 29A.32.280 provides that for each measure from a unit of local government that is included in a local voters' pamphlet, the legislative authority of that jurisdiction shall formally appoint a committee to prepare arguments advocating voter approval of the measure and a committee to prepare arguments advocating voter rejection of the measure, and

WHEREAS, Ordinance 16547, passed by the council on June 8, 2009, provided for submission to the

voters at the November 3, 2009, general election, of a proposed amendment to Section 800 of the King County Charter;
