BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. There is hereby approved and adopted an ordinance making a supplemental appropriation of \$315,507 from the current expense fund (salary and wage contingency) to licensing and regulatory services for costs associated with implementing the Animal Control Officers Guild collective bargaining agreement.
