AN ORDINANCE authorizing the vacation of a portion of Southeast Mud Mountain Road, File V-2518, Petitioner: Darrel Dickson for the Equanimity Foundation.

### STATEMENT OF FACTS:

1. A petition has been filed requesting vacation of a portion of Southeast Mud Mountain Road hereinafter described.
2. The department of transportation notified the various utility companies serving the area and has been advised that easements are not required within the vacation area.
3. The department of transportation records indicates that King County has been maintaining Southeast Mud Mountain Road. The records indicate that no public funds have been expended for its acquisition.
4. The department of transportation considers the subject portion of the right-of-way useless as

part of the county road system and believes the public would benefit by the return of this unused area to the public tax rolls.

5. The right-of-way is classified as "B-Class" and, in accordance with K.C.C. 14.40.020, the compensation due King County is based on seventy-five percent of the assessed value of the subject right-of-way, which was determined from records of the department of assessments. King County is in receipt of \$3,276.12 from the petitioner.

Due notice was given in the manner provided by law and a hearing was held by the office of the hearing examiner on the 19th day of April, 2006.

In consideration of the benefits to be derived from the subject vacation the council has determined that it is in the best interest of the citizens of King County to grant said petition.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. The council, on the effective date of this ordinance, hereby vacates and abandons that portion of Southeast Mud Mountain Road as quit claimed to King County by Donna and Herbert Snook on September 30, 1907, County Road Record 852, records of King County, Washington, as described below:

The Westerly 215.50 feet of the Southerly 12.00 feet of Southeast Mud Mountain Road (King County Road No. 852, formerly Archie Smith No. 2) right-of-way adjacent to the following:

The East 10 Acres of that portion of the West 1610 feet of the Southeast Quarter of Section 6, Township 19 North, Range 7 East, W.M., in King County, Washington, lying North of the White River and Southerly of Southeast Mud Mountain Road (King County Road No. 852, formerly Archie Smith No. 2).
