authorizing the executive to execute the franchise agreement.

## STATEMENT OF FACTS:

1. The Lakehaven Utility District has filed an application for a franchise in council districts 7

and 13 to construct, operate and maintain a sewer system to serve single family, multi-family,

and commercial properties in accordance with RCW 36.55.010 and K.C.C. chapter 6.27.

2. The Lakehaven Utility District 1999 Comprehensive Wastewater System Plan was approved on

March 26, 2002, by the King County council under Ordinance 14303.

3. The Lakehaven Utility District has an existing sewer franchise No. 12379, which is scheduled to

terminate in 2021. The existing sewer franchise agreement does not cover recently annexed area in the northeast portion of the district's service area.

4. The application has been referred to the relevant county departments for review.

5. The King County executive has recommended approval of the franchise.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

<u>SECTION 1.</u> The granting of a franchise to the Lakehaven Utility District to construct, operate and maintain a sewer system within King County is hereby approved. The King County executive is authorized to enter into and execute the sewer system franchise, which by this reference is fully incorporated herein. Said franchise shall include all of the general and special conditions required by the county.

SECTION 2. If within thirty days after the granting of this franchise, the applicant shall have failed to sign the written acceptance incorporated herein, then the rights and privileges granted herein shall be forfeited and said franchise shall be null and void. Said franchise shall replace and supercede any prior existing franchise granted to Lakehaven Utility District to construct, operate and maintain a sewer system within King

County. This franchise shall not impact any franchise granted to Lakehaven Utility District for the construction, operation and maintenance of a public water system within King County.
