AN ORDINANCE making supplemental appropriations of \$8,923,000 to the department of public defense and \$378,000 to public defender MIDD; and amending the 2015/2016 Biennial Budget Ordinance, Ordinance 17941, Sections 49 and 66, as amended.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. Ordinance 17941, Section 49, as amended, is hereby amended to read as follows:

PUBLIC DEFENSE - From the general fund there is hereby appropriated to:

Public defense \$((~~118,098,000~~)) 127,021,000

SECTION 2. Ordinance 17941, Section 66, as amended, is hereby amended to read as follows:

PUBLIC DEFENDER MIDD - From the mental illness and drug dependency

fund there is hereby appropriated to:

Public defender MIDD \$((~~3,269,000~~)) 3,647,000
