AN ORDINANCE establishing the health through housing fund; and adding a new section to K.C.C. chapter 4A.200.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

NEW SECTION. SECTION 1. There is hereby added to K.C.C. chapter 4A.200 a new section to read

as follows:

- A. There is hereby created the health through housing fund.
- B. The fund shall be a first tier fund. It is a special revenue fund.
- C. The director of the department of community and human services shall be the manager of the fund.
- D. The fund shall account for the proceeds of an additional one-tenth of one percent sales tax imposed

by the county as authorized in RCW 82.14.530.

E. Proceeds of the sales tax shall be used to fund affordable housing, housing-related services, the operations and maintenance costs of affordable housing and facilities where housing-related programs are provided, behavioral health-related facilities, newly constructed evaluation and treatment centers, and the operation, delivery or evaluation of behavioral health treatment programs and services, in accordance with RCW 82.14.530.
