BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. Ordinance 15026, Section 2, is hereby repealed.

SECTION 2. Subject to compliance with Ordinance 15026, Section 1, the council, on the date of adoption of this ordinance, hereby vacates and abandons all public rights of way within the area described in Attachment A to this ordinance. This includes but is not limited to right-of-ways as dedicated in Plat of State

Addition to the City of Seattle No. 5, Vo. 17, Pg 79, and as deeded by Quit Claim Deed Recording Number 5499671, Vol. 4337, Pgs 522-531 and corrected by agreement Recording Number 5536491 Vol. 4368, Pgs 462-463, as deeded by Warranty Deed Recording Number 7101290283, and as deeded by Warranty Deed Recording Number 7109210442, as granted by Recording Number 1399219, as granted by Recording Number 3027748 , all in records of King County, Washington, and as dedicated in Plat of Alder Grove Addition, unrecorded and any easement rights or rights of way that may have accrued to

the public through prescriptive means, lying within the area as described in Attachment A to this ordinance.
