AN ORDINANCE vacating of a portion of Southwest 152nd Street. File V-2398;

Petitioner Mark Gralia; and amending Ordinance 13986, Section 1.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

- 2) <u>SECTION 1.</u> **Purpose.** The purpose of this ordinance is to clearly define the legal description of the road area vacated in Ordinance 13986.
- 3) <u>SECTION 2.</u> Ordinance 13986, Section 1, is hereby amended to read as follows:
- 4) The council, on ((the 13th day of)) November 20, 2000, hereby vacates and abandons ((the east 238 feet
-)) <u>that portion</u> of Southwest 152nd Street as dedicated in the plat of Glen Acres, Volume 17 of Plats, Page 89, Records of King County, Washington, described as follows:

That portion of Southwest 152nd Street as dedicated in, Glen Acres, as per plat recorded in Volume 17 of Plats, Page 89, Records of King County, lying Easterly of a line described as following:

- 5)Beginning at the point of intersection on the north margin of said dedicated Southwest 152nd Street with the northwesterly line of Lot 29, Block 2 of said Glen Acres;
- 6)Thence East along the North margin said Southwest 152nd Street 56 feet more or less to the intersection with a line that lies 36 feet Southeasterly of and parallel with said Northwesterly line of Lot 29 and the TRUE POINT OF BEGINNING of the aforementioned line;
- 7) Thence South 51°12'58" West to the point on intersection on the South
- 8)margin of Southwest 152nd Street as said dedicated and the terminus of said line.
