AN ORDINANCE making a supplemental appropriation of \$475,000 to the building capital improvement fund to cover the costs of exploring options to reduce the county's dependence on lease space by either constructing a new building or purchasing an existing building, and to cover the cost of a consultant to complete the final feasibility analysis of a central steam plant designed to serve the county's central government buildings and Harborview Medical Center; and

amending the 2002 Budget Ordinance, Ordinance 14265, Section 119 and  
Attachment 2, as amended

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. There is hereby approved and adopted a supplemental request of \$475,000 to the building capital improvement fund 3951 for the purpose of providing the necessary appropriation authority to cover the cost of exploring options to reduce the county's dependence on lease space by either constructing a new building or purchasing an existing building and to cover the cost of a consultant to complete a final feasibility analysis of a central steam plant designed to serve the county's central government buildings and Harborview Medical Center.

From the building capital improvement fund there is hereby appropriated and authorized to be disbursed the following amounts for the specific projects identified in Attachment 1 to this ordinance:
