BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. The collective bargaining agreement and two memoranda of agreement negotiated between King County and International Federation of Professional & Technical Engineers, Local 17 (Court Reporters) representing employees in the superior court and attached hereto are hereby approved and adopted by this reference made a part hereof.

SECTION 2. Terms and conditions of said agreements shall be effective from January 1, 2010, through and including December 31, 2010.
