## BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. There is hereby approved and adopted a supplemental appropriation of \$81,331 to the superior court and a \$81,331 disappropriation from the current expense salary and wage contingency to implement the collective bargaining agreement negotiated between King County and the Local 2084SC-S (Superior Court Supervisors - Wages Only).
