<u>SECTION 1</u>. The collective bargaining agreement and memorandum of agreement negotiated between

King County and Public, Professional & Office-Clerical Employees and Drivers, Teamsters Local 763,

representing employees in the department of assessments and attached hereto is hereby approved and adopted

by this reference made a part hereof.

SECTION 2. Terms and conditions of said agreement shall be effective from

January 1, 2002, through and including December 31, 2003.
