AN ORDINANCE relating to the sale of the surplus property located at 56XX 328th Avenue NE, Carnation, Washington, in council district three.

**STATEMENT OF FACTS:**

For the property located at 56XX 328th Avenue NE, Carnation, Washington, located within council district three, the facilities management division completed the surplus property, affordable housing and public notice requirements.

**BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:**

**SECTION 1. Findings:** The sale of 56XX 328th Avenue NE through a negotiated direct sale is authorized under K.C.C. 4.56.100.A.2. because unique circumstances make the sale in the best interests of the

public. Unique circumstances are present because of a previously executed Memorandum of Understanding with the purchaser.

SECTION 2. The executive is authorized to convey the 56XX 328th Avenue NE surplus property to Phong Robert Cha consistent with a purchase and sale agreement substantially in the form of Attachment A to this ordinance and to take all actions necessary to implement the terms of the purchase and sale agreement.
