SECTION 1. The interest arbitration award agreement negotiated between King County and the King County Corrections Guild representing employees in the department of adult and juvenile detention and attached hereto is hereby approved and adopted by this reference made a part hereof.

SECTION 2. Terms and conditions of said agreement shall be effective from January 1, 2007, through and including December 31, 2010.
