AN ORDINANCE making a supplemental appropriation of \$4,000,000 to various funds for the purpose of constructing a community center in Lakewood Park; and amending the 2005 Budget Ordinance, Ordinance 15083, Section 114, as amended, and Attachment B, as amended.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. Ordinance 15083, Section 114, as amended, is hereby amended by adding thereto and inserting therein the following:

From capital improvement project funds there is hereby appropriated and authorized to be disbursed the

following amounts for the specific projects identified in Attachment A to this ordinance.

PROVIDED THAT:

Of this appropriation, no funds may be expended or encumbered on the Lakewood Park Community Center project 316560 until the executive transmits and the council approves by ordinance an agreement between the county and the Technology Access Foundation relating to the construction, ownership, use and operation of the facility.

SECTION 2. Attachment A to this ordinance amends Attachment B to Ordinance

15083, as amended, by adding thereto and inserting therein the projects listed in Attachment A to this ordinance.
