AN ORDINANCE relating to disclosure of interests by consultants providing professional or technical services as independent contractors to the county; and amending Ordinance 12138, Section 4, and K.C.C. 3.04.120.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

<u>SECTION 1.</u> Ordinance 12138, Section 4, and K.C.C. 3.04.120 are each hereby amended to read as follows:

((Contracts with private consultant firms or individuals)) Disclosure of interests by consultants.

- A.<u>1.</u> ((It shall be the duty of any private consultant firm and/or individual)) Each consultant entering into a contract((s with the county)) to ((perform studies)) provide professional or technical services to the county costing in excess of two thousand five hundred dollars ((to)) shall file both with the King County board of ethics and the executive a sworn written statement disclosing((:)) the following information:
- ((1.A)) a. any office or directorship in the ((firm)) consultant held by any county employee ((firm)) or any member of his or her immediate family;
- ((2.A)) <u>b.</u> any financial interest <u>in the consultant</u> held <u>or received</u> by any county employee((, his or her spouse,)) or any member of his or her immediate family ((in the firm)) as follows:
- $((a. \Theta))$ (1) ownership of over five percent of the stock or other form of interest in the ((firm, 0)) consultant; and
- ((b-R)) (2) receipt of any ((amount of salary)) compensation, gift or thing of value from the ((firm or individual))consultant;
- ((3.All)) <u>c. a list of all</u> contracts between the ((private consulting firm and/or individual)) <u>consultant</u> and the county in the five years immediately preceding the presently contemplated contract including the amount of money paid by the county to the ((eonsulting firm and/or individual)) <u>consultant</u> pursuant to ((the)) <u>each</u> contract;

- ((4.A)) <u>d.</u> any position or positions on any county board or commission, whether salaried or unsalaried, held by any officer or director of the ((firm)) consultant in the five years immediately preceding the presently contemplated contract; and
- ((5. The private consulting firm and/or individual shall further make known to both the King County board of ethics and the executive any other information known to it regarding any potential interest or conflict of interest other than that disclosed pursuant to the provisions of K.C.C. 2.14.010.)) e. any other information known to the consultant about any interest or relationship whatsoever between any county employee, including any member of his or her immediate family, and the consultant, other than that disclosed pursuant to subsection A.1. a through d of this section.
- 2. Unless otherwise specified in this section, the information disclosed shall cover the period twenty -four months before and including the date of filing the sworn statement.
- B. No payment shall be made on any contract with any ((private)) consultant ((firm and/or individual)) until five days after receipt by the board of ethics and the executive of the information required to be disclosed by this section.
- C. For purposes of this section, "consultant" means a person, as defined in K.C.C. 3.04.017, who by experience, training and education has established a reputation or ability to provide professional or technical services, as defined in K.C.C. 4.16.010, on a discrete, nonrecurring basis over a limited and preestablished term as an independent contractor to the county.
