SECTION 1. The collective bargaining agreement negotiated between King County and the Animal

Control Officers Guild representing employees in the animal control section of the records, elections and licensing services division of the department of executive services and attached hereto is hereby approved and adopted by this reference made a part hereof.

SECTION 2. Terms and conditions of said agreement shall be effective from January 1, 2001, through and including December 31, 2003.
