BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. The memoranda of agreement negotiated between King County and Service Employees International Union, Public Safety Employees, Local 519 ((Non-Commissioned) and (Communications Specialists)); King County Court Protection Guild (Court Protection Security Assistants); and the King County Police Officers Guild representing employees in the King County sheriff's office and attached hereto is hereby approved and adopted by this reference made a part hereof.

SECTION 2. Terms and conditions of the memoranda of agreement negotiated between King County and Service Employees International Union, Public Safety Employees, Local 519 ((Non-Commissioned) and (Communications Specialists)), shall be effective from August 26, 2003, through and including December 31, 2005.

Terms and conditions of the memorandum of agreement negotiated between King County and the King County Court Protection Guild (Court Protection Security Assistants) shall be effective from August 26, 2003, through and including December 31, 2006.

Terms and conditions of the memorandum of agreement negotiated between King

County and the King County Police Officers Guild shall be effective from August 26, 2003, through and including December 31, 2004.
