\$37,812.73; authorizing treasury operations to make the refunds.

WHEREAS, the department of assessments has determined a tax refund is warranted under the

provisions of RCW 84.69.020, and

WHEREAS, the taxpayers have filed untimely petitions for refund of taxes for 1980 through 2003, and

WHEREAS, RCW 84.69.030(2) precludes payment of refunds beyond three years, and

WHEREAS, pursuant to RCW 84.69.030, the council may act on its own motion to refund taxes when

the claim for refund is not filed within three years after making of the payment sought to be refunded;

NOW, THEREFORE, BE IT MOVED by the King County Council:
