## BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. From various funds there is hereby approved and adopted a total of \$781,847 to various

agencies to fund contractual increases provided for in the labor agreement between King County and Joint Crafts Council, Construction Crafts.
