AN ORDINANCE authorizing the county executive to enter into an interlocal agreement with the city of Lake Forest Park relating to the provision of incustody district court services.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. Findings.

- A. The city of Lake Forest Park ("the city") currently operates its own municipal court.
- B. The city contacted King County regarding the possibility of contracting for limited district court services, specifically, in-custody hearings on Saturdays and holidays.
 - C. King County is willing and able to provide the city with the limited in-custody district court services

it requested as outlined in the attached agreement.

D. King County and the city in negotiating this agreement created an arrangement that allows the city to receive the limited district court services it requested and allows King County to recover its costs in providing the services.

SECTION 2. The county executive is hereby authorized to execute an interlocal agreement, substantially in the form attached to this ordinance, with the city of Lake Forest Park to contract with King County for in-custody district court services.
