AN ORDINANCE authorizing the King County executive to enter into

amendments to interlocal cooperation agreements with the cities of Kent and

Seattle for the disbursement of conservation futures tax levy funds appropriated

under Ordinances 17232, 17349 and 17619.

STATEMENT OF FACTS:

1. King County conservation futures tax levy funds are collected throughout King County as a

dedicated portion of the property tax for the acquisition of open space and resource lands.

2. Ordinance 14714 established procedures for the annual allocation of conservation futures tax

levy funds, which direct the conservation futures citizens' committee to make funding recommendations to the King County executive to consider for inclusion in the annual budget ordinance.

3. Applications are posted on the conservation futures program web page on the King County website.

4. The executive received and considered the conservation futures citizens' committee funding recommendations and included them in his transmittal of Ordinances 17232, 17349 and 17619, by which the King County council has appropriated conservation futures funds for the open space projects listed and described in Attachment B to this ordinance.

5. King County desires to disburse conservation futures funds to the city of Kent and the city of Seattle, and to do so it must sign conservation futures interlocal cooperation agreements or amend existing conservation futures interlocal agreements with these jurisdictions.

6. The county and the cities are authorized to enter into an interlocal cooperation agreement pursuant to chapter 39.34 RCW, the Interlocal Cooperation Act.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. The King County executive is hereby authorized to enter into and execute amendments to interlocal cooperation agreements containing language substantially similar to that in Attachment A to this ordinance, necessary for the disbursement of conservation futures tax levy funds appropriated under Ordinance 17232,

17349 and 17619 to the projects listed and described in Attachment B to this ordinance, as adopted by the King County council.
