BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. There is hereby approved and adopted an appropriation of \$6,014,133 from the Harborview Medical Center/ medical examiner improvement 2000 projects subfund, to provide funding for programming and pre-design services and the remaining six months of 2002 for King County project oversight for the Harborview Medical Center/medical examiner stabilization and critical care expansion project.
