AN ORDINANCE making supplemental appropriations of \$2,810,627 to the

veterans and family levy, and \$649,098 to the human services levy; and amending

the 2012 Budget Ordinance, Ordinance 17232, Sections 69 and 70, as amended.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. To the veterans and family levy there is appropriated a total of \$2,810,627, amending the 2012 Budget Ordinance, Ordinance 17232.

To the human services levy there is appropriated a total of \$339,098, amending the 2012 Budget Ordinance, Ordinance 17232.

SECTION 2. Ordinance 17232, Section 69, as amended, is amended by adding thereto and inserting therein the following:

<u>VETERANS AND FAMILY LEVY</u> - From the veteran and family levy fund there is appropriated to:

Veterans and family levy	((\$7,829,283)) <u>\$10,639,910</u>

The maximum number of FTEs for veterans and family levy shall be 11.00

SECTION 3. Ordinance 17232, Section 70, as amended, is amended by adding and inserting the following:

HUMAN SERVICES LEVY - From the human services levy fund there is hereby appropriated to:

Human services levy	((\$7,829,283)) <u>\$8,478,381</u>
The maximum number of FTEs for human services levy shall be:	4.50

ER1 EXPENDITURE RESTRICTION:

Of this appropriation, \$310,000 shall be expended solely to contract with the following to provide shelter beds and services for homeless youth and young adults:

Auburn Youth Resources	<u>\$165,000</u>
Friends of Youth	<u>\$95,000</u>
<u>YouthCare</u>	<u>\$50,000</u>
