BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. The collective bargaining agreement and memorandum of agreement negotiated by and between King County and International Brotherhood of Teamsters Local 117 (Security Screeners) representing employees in the King County sheriff's office and attached hereto are hereby approved and adopted by this

SECTION 2. Terms and conditions of the collective bargaining agreement shall be effective from February 1, 2010, through and including December 31, 2014. Terms and conditions of the memorandum of agreement shall be effective from January 1, 2011, through and including December 31, 2014.
