WHEREAS, the work plan must address how to update the King County Strategic Plan, and

WHEREAS, the work plan shall provide for collaboration of the executive and council throughout the update process, engagement of separately elected King County government officials, and include a community engagement process to inform the update of the Strategic Plan, and

WHEREAS, the report describes a description of the approach to reviewing policies in the Strategic Plan with an emphasis on the council's role in prioritization, a description of the community engagement
