AN ORDINANCE approving an amendment to the sewer franchise for the city of Auburn in council district nine.

STATEMENT OF FACTS:

1. The city of Auburn filed an application to amend its franchise to decrease the service area included in their existing sewer franchise, located in council district nine.
2. The King County council approved the city of Auburn's comprehensive sewer plan amendment, in Ordinance 16937, pursuant to the recommendation of the King County utilities

technical review committee.

3. The utilities technical review committee has approved Auburn's franchise application as meeting the requirements of K.C.C. 6.27.060 and 13.24.010.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. The King County council, having determined that the city of Auburn's application meets the criteria for the granting of a sewer franchise amendment and that said granting is in the best interests of the public, does hereby approve the franchise amendment agreement set out in Attachment A to this ordinance and authorizes the King County executive to execute the same in substantially the same form as Attachment A to this ordinance.

SECTION 2. If within forty-five days after the granting of this franchise amendment agreement, the applicant shall have failed to sign the written acceptance incorporated herein, then the rights and privileges granted herein shall be forfeited and said franchise shall be null and void.
