BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. Ordinance 17695, Section 18, as amended, is hereby amended by adding thereto and inserting therein the following:

OFFICE OF PERFORMANCE, STRATEGY AND BUDGET - From the general fund there is hereby appropriated to:

Performance, strategy and budget

\$100,899

The maximum number of additional FTEs for the office of performance, strategy and budget shall be: 2.00

SECTION 2. Ordinance 17695, Section 44, as amended, is hereby amended by adding thereto and inserting therein the following:

<u>PHYSICAL ENVIRONMENT GF TRANSFERS</u> - From the general fund there is hereby disappropriated from:

SECTION 3. Ordinance 17476, Section 93, as amended, is hereby amended by adding thereto and inserting therein the following:

<u>DPER PLANNING AND PERMITTING</u> - From the DPER planning and permitting subfund for the 2013/2014 biennium there is hereby disappropriated from:
