AN ORDINANCE revising the road maintenance utility inspection fee for

right-of-way construction permits; amending Ordinance 7025, Section 3,

as amended and K.C.C. 14.44.045, adding a new section to K.C.C.,

chapter 4A.700 and recodifying K.C.C. 14.44.045.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

<u>SECTION 1.</u> Section 3 of this ordinance changes the fee for road maintenance utility inspections for right-of-way construction permits charged by the department of transportation, road services division.

SECTION 2. K.C.C. 14.44.045, as amended by this ordinance, is recodified as a new section in K.C.C. chapter 4A.700.

SECTION 3. Ordinance 7025, Section 3, as amended, and K.C.C. 14.44.045 are each hereby amended to read as follows:

A. ((The permittee)) <u>Applicants for construction permits within the King County right-of-way</u> shall pay an inspection fee at the rate of one hundred ((forty-nine)) <u>seventy-six</u> dollars per hour of utility inspection to the department of transportation, road services division. The fee((s-are)) is in addition to any other county fees and ((are)) is nonrefundable.

B. The fee((s)) shall be collected in accordance with administrative procedures developed by the department of transportation, road services division.

SECTION 4. This ordinance takes effect January 1, 2015.
