BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. The council is under an obligation by charter to enact revenue measures that support the

budget appropriation ordinance by December 1, 2014, for the 2015 budget. This ordinance sets the amount of

property tax to be collected for the regular property tax levy, the road district levy, the conservation futures

levy and the emergency medical services levy. In accordance with RCW 84.55.120, the council has given

proper notice of this ordinance to the public.

SECTION 2. For collection of the property tax levies in 2015, the council hereby authorizes property
