## BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. The collective bargaining agreement negotiated by and between King County and Teamsters Local 174 representing employees in the departments of natural resources and parks and transportation, which consists of Attachments A, B and C to this ordinance, and the memorandum of agreement regarding snow and ice, which consists of Attachments D and E to this ordinance, and the memorandum of agreement regarding 4-10 usage, which consists of Attachment F to this ordinance, are hereby approved.

SECTION 2. Terms and conditions of said agreements shall be effective from January 1, 2014, through and including December 31, 2016.
