## BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. The collective bargaining agreement negotiated by and between King County and

International Brotherhood of Teamsters Local 117 (Administrator I - Transit) representing employees in the department of transportation, which is Attachment A to this ordinance, is hereby approved and adopted by this reference made a part hereof.
