The collective bargaining agreement negotiated by and between King County and King County Juvenile Detention Guild (Department of Adult and Juvenile Detention - Juvenile Detention) representing employees in the department of adult and juvenile detention, which is Attachment A to this ordinance, is hereby approved and adopted by this reference made a part hereof.
