WHEREAS, the executive filed a report on a plan to manage updates to the King County Comprehensive Plan in 2015-RPT0030 and the plan was approved in Motion 14341, and

WHEREAS, the county executive transmitted to the council an initial follow-up report to the approved plan in 2015-RPT0118 and the report was accepted in Motion 14428, and

WHEREAS, the county executive has transmitted to the council a second and final follow-up report to

the approved plan regarding procedures to manage updates to the King County Comprehensive Plan in coordination with the department of permitting and environmental review and the newly formed regional planning section of the office of performance, strategy and budget, and

WHEREAS, the follow-up report contains the following:

- 1. A statement as to whether the milestones in the approved plan were achieved and, if not, an explanation of why not; and
- 2. Whether the approved plan allocating the work to be performed between the department and the regional planning section was followed and the coordination achieved and, if not, an explanation of why not, and

WHEREAS, the council has reviewed the report submitted by the executive;
