AN ORDINANCE relating to cultural development authority proviso

requirements; and amending the 2015/2016 Budget Ordinance, Ordinance 17941,

Sections 74 and 74, as amended.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. Ordinance 17941, Section 74, as amended, is hereby amended to read as follows:

CULTURAL DEVELOPMENT AUTHORITY - From the arts and cultural development fund there is

SECTION 2. The council directs that section 1 of this ordinance takes effect before section 3 of this

SECTION 3. Ordinance 17941, Section 74, as amended, and as amended by section 1 of this ordinance, is hereby amended to read as follows:

<u>CULTURAL DEVELOPMENT AUTHORITY</u> - From the arts and cultural development fund there is hereby appropriated to:

\$((55,597,000)) <u>57,597,000</u>

P1 PROVIDED THAT:

Of this appropriation, \$2,000,000 shall be expended or encumbered solely for the preservation action fund. Of that amount, funds shall not be expended or encumbered until the executive transmits an agreement between the county and 4culture on how the preservation action fund will be administered and governed and an ((motion)) <u>ordinance</u> that approves the agreement, and the ((motion)) <u>ordinance</u> is passed by council. The ((motion)) <u>ordinance</u> shall reference the subject matter, the proviso's ordinance, ordinance section and proviso number in both the title and body of the ((motion)) <u>ordinance</u>. The executive must file the ((motion)) <u>ordinance</u> required by this proviso by February ((4)) <u>16</u>, 2016, in the form of a paper original and an electronic copy with the clerk of the council, who shall retain the original and provide an electronic copy to all councilmembers, the council chief of staff, the policy staff director and the lead staff for the budget and fiscal management committee or its successor.
