WHEREAS, the 2015/2016 Biennial Budget Ordinance, Ordinance 17941, Section 121, as amended by Ordinance 18110, Section 55, Proviso P1, states that \$720,000 of the appropriation to the facilities management internal service fund shall not be expended or encumbered until the executive transmits a scoping report on the

WHEREAS, the scoping report is submitted by the facilities management division to fulfill the proviso obligation regarding the civic campus plan;
