BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. A. King County and the Washington state Department of Corrections have participated in interagency agreements for many years. The current interagency agreement expired on December 31, 2015.

B. King County and the Washington state Department of Corrections have now negotiated a new
