SECTION 1. The memorandum of agreement negotiated by and between King County and International Association of Fire Fighters, Local 2595 (Paramedics, Emergency Medical Services - Department of Public Health) regarding the merger of Vashon's Advanced Life Support services into the King County Medic 1 system representing employees in the department of public health, which is Attachment A to this ordinance, is hereby approved and adopted by this reference made a part hereof.

SECTION 2. Terms and conditions of said agreement shall be effective from October 1, 2016, through and including December 31, 2017.
